Zoning Ordinance Amendment - Update

Brian Carl stated that a draft amendment was prepared because vacation resort was mistakenly removed from our ZO and the definition of agriculture was also expanded to further explain that even small lots can perform AG operations. This amendment will be reviewed by the Planning Commission on 1/30/2025.

I-78 West Bound/863 - Traffic signal battery backup.

A motion was made by Anthony Werley, seconded by Richard Bleiler to approve the installation of a battery backup system on the traffic signal at I-78 West Bound/863 and replace the preemption device on the WB I-78 ramp for a cost not to exceed \$9,950 to CM High Inc. Motion carried 3-0

Traffic signal maintenance agreement.

A motion was made by Richard Bleiler, seconded by Anthony Werley to approve the maintenance agreement with Telco for the traffic signal for \$900. Motion carried. 3-0

Tercha Land Preservation

Discussion was held with the Board and Peter Lehr regarding the land preservation of Kate Tercha. Kate is no longer interested in participating in the State/County program however she is willing to preserve the 196 +/-acres exclusively with the Township for the Township's original pledge of \$200.00 per acre. Brian and Peter will work with Kat to develop a preservation easement modeled off of the Wildlands Conservancy and previous Township Easements.
