### Weisenberg Community Center - Advisory Committee Comments

Brian Carl informed the Board that construction will begin at the community center next week. A tag line for the community center was voted on by the committee and the most popular line was "Where Neighbors Gather". The Board of Supervisors agreed with the tag line so that it can be implemented in correspondence for the Community Center. We will hold a logo contest with entries due 10/31/25. Brian presented a draft fee schedule for the use of the room and field in the Community Center as well as membership rates. The fees were not adopted at this time however the Board was in agreement that they are in a good ballpark.

Marty Rakaczewski informed the Board that the EAC will be participating in the upcoming Weisenberg Fire Department Community Day that is taking place September 13 at the Weisenberg Fields. The EAC also performed a litter clean-up along Seipstown Road. They also cleaned up around the gazebo.
