Public Hearing - South Kistler Court - Road Vacating

A hearing was held at 7:01pm to take comments from the public regarding the proposed ordinance which will vacate South Kistler Court (T-553). There was no public comment, so the hearing was closed at 7:02pm.

South Kistler Court - Road Vacating - Ordinance

Motion made by Anthony Werley, seconded by Richard Bleiler to adopt Ordinance #2025-6 vacating South Kistler Court (T-553). Motion carried. 3-0

New Business

Brian Holben - 7685 George Road - Driveway Permit Waiver

Mr. Holben addressed the Board with his request for a driveway waiver. Mr. Holben provided photos of his installed (without a permit) concrete driveway and explained the construction/slope of the concrete. Concrete driveways are not permitted within the first 25' of the edge of an asphalt road on Township roads. Anthony Werley will meet with Mr. Holben and the driveway installer to discuss what needs to be corrected regarding the driveway swale, and removal of the concrete portion of the driveway that meets the road surface and regrade/replace with asphalt. Mr. Holben may return with a waiver request of the 25' requirement as long as the swale can be installed and the slopes can comply within a shorter distance.

Motion made by Anthony Werley, seconded by Richard Bleiler to deny the driveway waiver request and to reject the driveway application. Motion carried. 3-0

West Hills – I-78 Eastbound Ramp Traffic Signal 18-month Maintenance Period Bond

Barry Isett has inspected the traffic signal installed at the Eastbound Ramps of Interstate 78 and Route 863 and found the signal to be operating per design with no defects in materials or workmanship.

Motion made by Richard Bleiler, seconded by Anthony Werley to approve the bond reduction from \$101,000.00 to 59,885.63 and to start the 18-month maintenance period for the I-78 Eastbound Ramp Traffic Signal (expiring in May 2026). Motion Carried. 3-0

Motion made by Anthony Werley, seconded by Richard Bleiler to appoint Eric Erb (Keystone Consulting Engineers) as an alternate Sewer Enforcement Officer for Weisenberg Township. Motion carried. 3-0

Jeff Broadhurst, President, informed the Board that they ran 17 calls for the month of May 2025. He reviewed the Fire Department's comment letter dated 6/9/2025 regarding the activity of the fire department for the month of May and upcoming events, grants and membership.

Brian Carl informed the Board that the 1st meeting was held right before this meeting with a dozen or so community members from various fields of interest. We will be holding these meetings regularly to discuss what kind of activities we want to see at the community center and will be reporting this back to the Board.

Roadmaster's Comments

Anthony Werley stated that they continue to mow grass and scratch paving was also performed last month. They helped Heidelberg Township with their paving projects. They are also boom mowing and weed whacking around guiderails/signs. They also replaced (4) pipes on Tri-Township Road and (1) on Spring Road. Equipment was prepared for sale on Municibid. Oil & Chipping was pushed back by the contractor.

Motion was made by Richard Bleiler, seconded by Linda Gorgas to approve the purchase of a new/larger snowplow for \$8,078.00 from E.M. Kutz, Inc. for Truck # 33. Motion carried. 3-0

Motion was made by Anthony Werley, seconded by Richard Bleiler to approve the proposals from R.S. Snyder Enterprises, Inc. to sealcoat the Fire Department's driveway/parking lot and Bachelor Road Fields driveway/parking lot. The optional line painting was not accepted. Motion carried. 3-0

Engineer's Comments

Stan Wojciechowski stated that the surveyors were out at the Blacksmith Road culvert location and completed the base plan. They are currently running a modeling program to determine the size opening that is needed.

Treasurer's Comments

Jeff Strauss stated that 95% of our real estate taxes have been collected in the discount period. The Northwestern School District tax bills will be going out to residents July 1st with an increase of 3.5%. ACH forms are being signed in order for direct payments to be sent to Conestoga Builders for the Community Center progress billing. New Tripoli Bank would prefer all vendors to be paid by ACH due to the increase in mail fraud. Jeff has not received a response from AT&T regarding the payment of legal fees. Peter Lehr will contact them regarding this at no charge.

Supervisor's Comments

Richard Bleiler informed the Board of incidents that occurred during NYAA sporting events at the REC fields and Bachelor Road. President, Amy Fatzinger, would like the support of surrounding municipalities regarding unruly parents. The Nesting Box will have a food truck at the REC fields for upcoming sporting events.

Linda Gorgas stated that she has received complaints about dog waste around the walking trails at our 2 parks. Brian Carl stated that the Township has dog waste stations at both parks and residents are reminded to use this facility. He will also post on Facebook to remind residents to collect their pet waste and dispose of it properly.
